## **Job Summary**

The Project Technical Supervisor will provide onshore and offshore expertise for all operational projects and in particular special projects that are not related to normal geotechnical operations of the equipment.

He/she will also ensure achievement of the plan in terms of quality, time, and budget in compliance with the Company's HSSE and technical standards as well as established policies and procedures. The incumbent will be based onshore, but will mobilise offshore on a regular basis to support specific breakdowns, changeouts and maintenance scopes.

## **Functions and duties**

The duties assigned to the Technical Supervisor (Project) will be varied; these will include but not be limited to the following:

- Ensure self and team carry out duties in accordance with all Health and Safety procedures, Codes of Practice and Statutory Regulations
- Ensure all tasks are carried out to the highest standard and that work is completed on time, within budget.
- Build effective relationships with internal departments, answering queries, keeping them informed about the project and its developments.
- Monitor, co-ordinate and manage services provided by specialists and/or sub-contractors.
- Take the lead in planning and organizing tasks for all technicians before the start of a shift when on site and prior to arriving for project start if any preparations are needed and can be executed.
- Ensures all health, safety, and regulations are followed and improved on when opportunities arise.
- Work with Rig management teams and offshore/ onshore technical teams ensuring all planned maintenance is compliant with manufacture recommendations and additional maintenance as required.
- Work alongside maintenance planner to develop and maintain scheduling for routine and preventative maintenance.

- On site assessment of problematic equipment and planning remedial action, repair/replacement/upgrade etc.
- Excellent industry knowledge sufficient to source and specify all required mechanical and hydraulic equipment to perform repairs/upgrades.

- Monitoring of daily reports detailing work carried out and following up with additional maintenance/repairs/modifications where required.
- Writing/reviewing mechanical maintenance/repair procedures.
- Ensure any modifications to equipment are performed in accordance with company MOC procedures and documentation is updated accordingly.
- Attend vessels for maintenance and repairs where required.
- Provide technical assistance to offshore personnel.
- Any other duties deemed necessary, which are within the boundaries of the incumbent's competence and function.
